Cochran, Andrew "Drew" Lamont Jr., 76, Sweetwater NJ, passed away on Sunday, March 18, 2018. Born in Camden in 1941, raised in Collingswood and Lake Pine, Drew graduated Rancocas Valley High School in 1960. Drew married his wife of 55 years, Margie, in 1963.

Drew lived most of his life in the Medford Lakes and Sweetwater areas. Drew, a veteran of the United States Air Force, was a lifelong sales professional in the automotive aftermarket industry. He loved boating on the Mullica River, trips to Motts and the Sweetwater Casino. Earlier in life, Drew was active with the Pine Barrens Enduro Riders, the Sweetwater Yacht Club and he enjoyed horseshoes and darts with his buddies.
